

## Rules Park & Win

These regulations set out the practical course of events with regard to the Park & Win promotion.

1. Truckparking Duiven (Parking Facility Liemers (P.V.L.) B.V.) and Truckparking Hazeldonk (TRE Hazeldonk Exploitation B.V.) jointly organize a Park & Win promotion.
2. Participation in the promotion is open to all natural persons aged 18 and older who have received a valid ticket for the truck parking in Duiven and / or Hazeldonk.
3. The person participating in the promotion is bound by the provisions of these regulations. A copy of these regulations, in its current form, can be found on [www.truckparkingduiven.com](http://www.truckparkingduiven.com) and [www.truckparking-hazeldonk.com](http://www.truckparking-hazeldonk.com).
4. Participation in the campaign is voluntary and is initiated by mentioning an e-mail address on the back of the parking ticket received on entering the secure truck parking.
5. When leaving the secured truck parking, the relevant parking ticket is taken automatically by the parking ticket (immediately before opening the speedgate, as part of the normal exit procedure).
6. The leaving behind a legible and valid e-mail address (on the back of a parking ticket) makes someone a participant of this promotion.
7. The number of times someone participates is not limited and participation in this promotion itself is free of costs other than the regular parking fee.
8. When the parking machine is emptied by Truckparking Duiven staff and / or Truckparking Hazeldonk, all parking tickets that are provided with a legible and valid e-mail address will be collected.
9. The promotion runs from 1 April 2018 to 30 November 2018
10. Every fourth working day of the month (for the first time on May 4, 2018, for the last time on December 6, 2018) a draw will take place. The draw will be provided by a (random) driver present at the parking lot. The draw will take place 'blindly' and this will make all parking tickets from the calendar month a chance to be drawn. 10 parking tickets are drawn to make sure that enough valid tickets have been selected (readability and correctness of e-mail address).
11. The first ticket that is provided with a readable and valid e-mail address in the order of the draw wins a gift voucher of €250 and the next two a gift voucher of €100.
12. All participants will be informed by e-mail about their possible prize and can collect them after consultation on a subsequent visit to the truck parking.
13. The prizes consist of gift vouchers that are valid at Truckstop Joost (Hazeldonk and Meer, NOT in the online shop), respectively €250 (once a month, 8 times total) and €100 (twice a month, 16 times total).
14. The gift vouchers are valid for 6 months and are not exchangeable for money.
15. Parking facility Liemers (P.V.L.) B.V. and / or TRE Hazeldonk Exploitation B.V. is / are not liable for the disadvantages arising for a participant from non-compliance with the regulations laid down in these regulations.
16. The names of the participants or prize winners may only be disclosed to a third party or third parties with their explicit consent.
17. Parking facility Liemers (P.V.L.) B.V. and / or TRE Hazeldonk Exploitation B.V. is / are not liable for errors or negligence of Joostshop and / or third parties in the delivery and issue of prizes in kind.
18. There is no correspondence about the result.
19. In all cases not covered by these regulations, the management of TRE Hazeldonk Exploitation B.V. ..
20. The management of TRE Hazeldonk Exploitation B.V. is entitled to postpone a draw if, in its opinion, a proper course thereof is likely to be jeopardized.
21. Dutch law applies to these regulations.
